



Northwest Wyoming Board of Realtors Application for MLS Committee

Multiple Listing Service Operated as a Committee of the Association

The Service shall be managed by a Committee of five persons (**MLS Participants**) who shall be elected by the members of the Multiple Listing Service from its membership at a meeting to be held in August of each year at the same time as the election of Association Officers. The Committee shall serve on a rotating 3-year term.

This Committee is to provide a forum for the discussing of problems encountered in the MLS Service and to ensure compliance with the Rules and Regulations of the MLS and the National Association of REALTORS®. The Committee shall meet for the transaction of its business at a time and place to be determined by the Committee or at the call of the Chairperson. The Committee may call meetings of the Participants in the Service to be known as meetings of the Multiple Listing Service. **All members of the Committee shall be participants of the Multiple Listing Service.** The Committee shall select its Chairperson from among the members at the first annual meeting of the year.

Confidentiality of MLS Information:

Any information provided by the Multiple Listing Service to the Participants, shall be considered official information of the MLS. Such information shall be considered confidential and exclusively for the use of Participants and real estate licensees affiliated with such Participants and those Participants who are licensed or certified by an appropriate state regulatory agency to engage in the appraisal of real property and licensed or certified appraisers affiliated with such Participants.

Attendance. Absence from three regular meetings in one year by an elected officer, result group chairman or a Director (committee member) without an excuse deemed valid by the Board of Directors (Committee) shall be construed as a resignation from the office or directorship and said position may be declared vacant by the Board of Directors (Committee) according to Article XII, Section 2 of the Bylaws.

The Executive Officer shall make note in the minutes as to who is present at the meetings and send written notification to non-present members as to their status due to their absence. A copy of all such letters shall be retained on file with the Executive Officer on a year-to-year basis.

Acceptable excuses for absences from regular meetings shall be: (1) Medical, family medical, illness or death in the family, (2) Legal proceedings, (3) Vacation, and (4) REALTOR®-related education or meetings (not showing property, meeting with clients or other regular Realtor®-related activities).
